Bob McLaughlin has served as an ADD for Ron Verblauw, Bill Sachs, and also for me. He was a member of the

G1 committee, was my first assistant, and was the source of several outstanding ideas including the Transition Team, Value Added, and the Program Management Refresher. I'm sure Bob will be an outstanding contributor to the new BOD.

Pamm Ferguson has been an ADD since I became division director. She supported three regions on the western end of the division as well as the S&T and Certified programs. Pamm was a strong supporter and participant in the Women's S&T clinics.

Both Bob and Pamm were selected by all of the members of the nomination committee from a field of over 33 applicants for the new BOD. Former Division Director and current National Chair Bill Sachs was also unanimously selected and will likely continue to lead our organization in that position. The new BOD is not representative, it is knowledge-based, much like the BOD of a large corporation, but we can still take comfort in the fact that three of the thirteen members call the Eastern Division home.

exciting time for me is that I get to bring in some new folks as ADD's. I was very happy with the job that Bob and Pamm were doing, but I am always looking for people who are making an extra effort. I have asked all of my staff, both program supervisors and assistants, to be on the lookout for new talent.

In the past, most ADD's have been line officers...region directors or section chiefs, elected in their regions, who have done an above average job of coordinating the activities of program administrators and others. Over the past few years we have asked all line officers, program supervisor, and administrators to focus on making NSP programs available to every member. I am happy to announce that in keeping with that focus I have named two program supervisors to vacant ADD positions.

Dave Walker has served for many years as the Division S&T Supervisor. Dave can be credited with many innovations including the creation of a steering committee to help administer the program, a concept that we now have adopted in the OEC. Under

Dave's leadership, Women's Clinics, Toboggan Enhancement Seminars, and Skier Enhancement Seminars have also become popular. Dave will continue as S&T Supervisor for a few months before turning the reins over to his successor, Randy McNeil. As an ADD, Dave will support S&T, Certified, and will be the liaison between the Eastern Division and the Pro Division. Dave will also support the Maine, New Hampshire and EMARI Regions. I have always enjoyed working with Dave and am very happy to have him as an ADD.

Marcia Mundrick, our current Instructor Development Supervisor, also joins my staff as an ADD. Marcia, an educator by profession, has always been an outstanding teacher of teachers whether we called it Phase I or Instructor Development. She is a former region director and is well known throughout the division. Marcia always asks the tough questions and looks at every issue from the average patroller's point of view. She will support the Genesee Valley and Western New York Regions as well as the Avalanche, Mountain Travel and Rescue, Nordic, and Instructor Development programs. At this time I have not identified her successor.

Eastern Division Transition Team Progress Report September 2002

At the 2002 Spring Officers' Meeting, Division Director Jerry Sherman introduced the nine patrollers selected to make up the division's transition team. The team is charged with identifying the guiding principles and being the "architect" to assist the division in any programmatic and/or structural changes occurring as the division deals with the changes at the national level. The team has met three more times since April and identified three areas of importance to its activity:

- program delivery
- the organizational structure best suited to accomplish program delivery
- the need for patroller/member satisfaction

At the fall meeting in Albany, Rick Andriole, team leader, and several other team members presented the line officers in attendance with a report on their progress. The ensuing discussion was positive and helpful to all. The team plans to meet in November to review the comments, suggestions, pros/cons, etc. that came out of the fall meeting.

The Transition Team would like to request your patience and your help as it continues to struggle with its task. Although the new national bylaws, already adopted, allow divisions to determine their own fate, structure, etc. the issues are still so nebulous it may not be possible for the team to have a clear plan for presentation at the spring meeting. However, that will continue to be our goal.

The members of the team will make every effort to communicate via *TRAIL SWEEP* or other means to keep people informed of our progress. In addition the team welcomes any input from patrollers, so please feel free to contact any team member listed below.

What's a mentor? As you know, the Phase II program no longer exists. Instructor candidates will have a mentor to assist them through the training process. Assigned to a new trainee by the program's leadership, a mentor can help access lesson plans, assist the trainee with classroom management and paperwork, and help the trainee gain confidence in his/her teaching skills through observation and critique. Basically, you can be a knowledgeable friend that helps a new instructor to "learn the ropes." Your Instructor Development instructors can provide a mentoring guideline sheet to assist you through your mentoring activities.

Attention "experienced instructors"... "speaking the same talk"

You've heard by now that the Instructor Development course has gone through some changes. One change is the term 6-pack. New instructors will be calling the two parts in the heart of the lesson *content delivery* and *student activities* instead of input and output. I think the new terms better describe the purpose of those parts of the lesson.

Also, instead of evaluation, the title is now *monitoring and evaluation*, to emphasize that these concepts should be ongoing throughout the lesson. If you want further information, talk to the Instructor Development instructors in your region.

Early in my teenage years I applied to the Mt. Tom Ski Patrol in Western Massachusetts as a junior patroller. It was a teenager's dream come true, free skiing...all I wanted, and they even gave us lunch coupons when we worked. My parents had been on the patrol for several years before I was old enough to participate. The Mt. Tom patrol management decided to try junior patrollers to see if they would work out.

My first year was very trying because I was only able to squeak out about 80 days of skiing. To make matters worse the other five patrollers that participated in this junior trial year were girls. Imagine a teenager, with plenty of time on his hands, a pass that allowed free skiing anytime he wanted, working with five teenage girls...what an introduction into patrolling! It just wasn't going to get any better than that.

My patrolling career took me to Eastern Massachusetts where I worked for a couple of years at a small area called Pheasant Run. After they closed I took a patrol job at Wachusett Mountain where I am currently the patrol director. I was the assistant patrol director there for about fourteen years prior to taking the director's job.

I have been involved in many levels of patrolling including appointment as my region's ski and toboggan and first aid advisor (pre-OEC). As a member of the Professional Ski Patrol Association I served as president, secretary, and first aid chairman. I hold National Certified #372, PSPA certified #9005 and am an examiner in both organizations. For the last nine years, I have been the Eastern Division Ski and Toboggan Supervisor working with their steering committee to improve program delivery within the discipline. I have traveled all over the division and continue to be impressed by our patrollers whose dedication and enthusiasm makes this sport safer. Senior EMM

Plan to participate in a very worthwhile education program this season. What's in it for you? You don't get any free lift tickets, no bonuses – just the satisfaction of learning and improving your own skills and knowledge base.

Senior Emergency Management Module (previously known as Senior OEC) uses assorted scenarios to help you improve your skills in three major areas: Decision Making, Problem Management, and Leadership. It is *not* a higher level of Outdoor Emergency Care. We only have one level of care, and that is the standard set by our Outdoor Emergency Care text.

Talk to recent participants of the program. They will tell you that they learned and developed skills which help them to manage complex situations and to consider many more details than just OEC performance.

The Senior EMM program requires that you participate in a number of training clinics in which specially trained senior trainer/evaluators help you learn some advanced management skills. At the conclusion of a training schedule, a final evaluation is scheduled and it is nothing more than what has been practiced in the training clinics – it is a reinforcement of learned principles.

Improve your skills – add more value to your patrol with the learned ability to lead others - who knows, it could even assist you in your chosen vocational field.



A Brief Description of Programs Offered by the Eastern Division

Telemark Enhancement Seminar:

The telemark enhancement clinic is open to any patroller presently patrolling on telemark equipment, who wants to improve their telemark ski skills. LLEWELLYN "BUD" TUCKER

It is with deep regret that we report the sudden passing of Llewellyn "Bud" Tucker on June 15, 2002 at the age of 69.

Bud was a 43-year veteran of the NSP and had worked at Mount Greylock, Brodie Mountain, Berkshire East, and Otis Ridge Ski Areas. His involvement had been both long and dedicated since its inception in 1959. He served as Brodie Mountain Patrol Director twice, 1966-1979 and 1997-1999.

During the 1965-66 season Bud served as his region's first aid advisor and in 1968 he stepped down from the patrol director's position to become the Berkshire Section Chief of the Western Massachusetts Region.

It was in Bud's nature to be constantly involved in all facets of patrolling and he led by example. He continually strove for improvement advancing through the senior and certified programs and serving as both an S&T and OEC trainer/evaluator at the patrol, region, and division levels. He received his Circle A and Avalanche Patch in 1968 and went on to become an instructor in the program.

In 1970 he achieved PSPA Certification and during the 1971 season, in the second year of its administration, Bud passed the Certified Exam receiving certified number 18. He became a valued contributor to the program serving as both its secretary and cochairman. In 1999, the Certified Program honored Bud with Lifetime membership status.

Bud was recognized by his peers and received many honors for his dedication to the NSP. In 1968, Minnie Dole presented Bud with National Appointment #3250. In 1985 he was awarded the Western Massachusetts Region Director's Award for the outstanding volunteer in the region and in 1987 received a Yellow Merit Star.

Bud graduated from Syracuse University with a Bachelor of Science in 1954 and was employed at Crane & Company, Dalton, MA for 37 years, retiring from the Quality Control Department in 1995. He was a member of the Technical Association of the Pulp and Paper Industry and served on the Executive Committee for the Berkshire Section.

From 1954-1957 he served in the Army subsequently transferring to the Coast Guard Reserve. He retired as a Commander in 1993 and was a member of the Reserve Officers Association.

An avid sailor and sports car enthusiast, Bud was a member of the U.S. Power Squadron, Pontoosuc Sailing Club (past commodore), Shennecossett Yacht Club, and the Sports Car Club of America. He received his competition license in 1965.

Bud is survived by his wife, Laura; children, David, Carol, Edward, Michael, and Karen; stepchildren, Wendy and Ward; grandchildren, Nathan, Sarah, Michael, Stephanie, and Courtney; and sisters Lucille and Grace.

Family and friends gathered at Brodie Mountain in New Ashford, MA on September 28, 2002, in remembrance of Bud. His quiet manner, his willingness to help other patrollers, and quest for NSP excellence will be missed by his family, friends, and the Eastern Division patrol community. BARBARA CHANDLER HODGSKIN (1929-2002)

Barbara "BOO" Hodgskin, started skiing with the patrol in 1969. Initially, Boo was an instructor for the Tiny Tots program at Labrador Mountain when she began training as a patroller. She was also a member of the first EMT class in New York State and became a Red Cross First Aid Instructor. Her patrol career included FA/PEC/WEC Instructor, Senior Patroller, Senior First Aid Examiner and Instructor, Trainer/Evaluator, Chief-of-the-Hill, and Patrol Board Member-at-Large. Boo received National Appointment #4594 in 1975 and a Yellow Merit Star for assisting in saving a life during a patrol rescue. This year she was awarded the prestigious Distinguished Service Award, the first in the history of the Labrador Mountain Ski Patrol.

Year after dedicated year, Boo worked tirelessly at refreshers, clean-ups, hosting West Point cadet patrollers, maintaining the most patrolled hours, championing our fundraiser "RoundUp" and becoming a known face to many on the hill and mentoring incoming candidates. Boo has done so much for our patrol that we wouldn't be what we are now if it hadn't been for her.

If you've ever skied at Labrador, you might know that Boo and her husband Hodge had a ski house on the hill at the top of the Badger Chair. All were welcome at Boo and Hodge's winter home to share a hot cup of coffee and talk about skiing. Boo's tracks were usually the first seen on the hill, meandering out of the woods from her cottage, making perfect s-curves on her way down to start the day. She was tireless, devoted to the sking and boarding public, dedicated to the national patrol she served, and loved by her fellow patrollers.

Her family sent us this note which best describes her: "Boo was laid out in her rust and blue patrol parka, which coincidentally was matched by the magnificent floral arrangement sent by the patrol. Boo was always so proud to be part of the Labrador Ski Patrol in large measure because of the dedication and commitment of its patrollers. It was her kind of thing. She was never happier than to make First Tracks down Badger before the lifts opened on a frosty, winter day with maybe a dusting of powder from the night before. Whenever you make First Tracks anywhere, think of her. She won't be there, but her spirit will."

Eastern Patroller Skill Competition

The third annual Patroller Skill Competition will be held at the Montage Ski Area on Saturday, February 9, 2003. The registration fee is \$40 per team (after February 1 the fee is \$50) with the team consisting of three patrollers of any classification and one patroller to evaluate the OEC scenarios and assist on the race course, three patrollers of any classification and one patroller to evaluate the OEC scenarios and assist on the racecourse.

Each team member will receive a T-shirt and lunch. The event planners hope to up the prizes once again and to possibly include an AED along with the Cascade Toboggan and cash.

Last year's competition saw Team Roundtop take the first place trophy cup, a Cascade Toboggan and \$500. Their team consisted of one certified patroller, Brant Maley, and two student patrollers, Krista Bensel and Ian Shedder. You may recognize these students' names because Krista took first in skiing and Ian took first over all at the Division Student Patroller Competition last March. The defending champions Team Jack Frost came in a close second taking home \$200 and Team Montage finished up in third with \$100.

The rules have not changed much from the first year the competition was held. Each competitor will lead a basic OEC scenario. There are NO extractions, unresponsive, uncooperative, or multiple patient scenarios. The leader and his/her team will be evaluated on:

- 1) scene hazard control
- 2) introduction to patient
- 3) body substance isolation
- 4) patient survey
- 5) identification of injuries
- 6) SAMPLE history
- 7) base line information
- 8) applied OEC
- 9) patient handling
- 10) time used (20 minute maximum allowed).

The timed race will be two runs with an empty sled and two runs with a loaded sled down a NASTAR-style course. These rules may be modified by the event planners to adjust for weather, conditions, or the number of teams competing. 2003 Level II Avalanche Course

The 2003 Eastern Division Level II Avalanche course has been scheduled for March 6 through 9 (Thursday through Sunday) at Whiteface Mountain, NY. The course will run four consecutive days in order to minimize time and travel commitments for those involved. Participants should plan to arrive Wednesday evening. The purpose of the Level II course is to help prepare the patroller for all aspects of avalanche rescue operations.

During the first two days, participants will complete the classroom program by attending a wide variety of presentations and activities, and by direct involvement in a rescue simulator session. The simulator is a mock-up of a rescue problem designed to provide realistic situations and decision-making typically encountered in avalanche rescue operations. The next two days comprise the field portion of the course. Participants will be involved in field exercises including snowpack analysis, rescue beacon use, and avalanche rescue operations.

The Level I Avalanche or the Avalanche Fundamentals and Rescue (formerly called Basic) course and the Level 1 (also formerly called Basic) Mountain Travel and Rescue course are required as prerequisites. Winter hiking experience and proper outdoor clothing and equipment are essential. Interested patrollers must understand that a significant outdoor exercise is done in a winter mountain environment and those with physical or medical restrictions must consider these factors before applying.
